1. Submit this completed and signed application by email or postmarked no later than 11:59 PM on June 30, 2022 to the President of the Imperial Court of New York.
2. Submit a minimum of two (2) signed letters of recommendation from individuals not associated with the Imperial Court System individuals with the completed application.
3. Be an Imperial Court member in good standing.
 - a. *Per the Imperial Court of New York Bylaws, a member in good standing is one that has paid their annual membership dues (Section 2.02.2) and attended (6) General Membership Meetings and/or Board of Directors Meetings in the current fiscal year (Section 2.02.3).*
4. Have been an active member in good standing for a minimum of three (3) complete years of service at the time of application.
5. Have chaired or co-chaired an ICNY-related event and a Night of a Thousand Gowns (NOATG) committee.
6. Have excellent Communication Skills.
7. Have attended a minimum of four (4) out of town coronations within two years preceding submitting the application.
8. Actively participated in at least six (6) in-town Court related events.
9. Have performed in or hosted an ICNY Court related event.
10. Not been convicted of a felony within the last seven (7) years.
