- 2. Submit a minimum of two (2) signed letters of recommendation from individuals not associated with the Imperial Court System individuals with the completed application.
- 3. Be an Imperial Court member in good standing.
  - a. Per the Imperial Court of New York Bylaws, a member in good standing is one that has paid their annual membership dues (Section 2.02.2) and attended (6) General Membership Meetings and/or Board of Directors Meetings in the current fiscal year (Section 2.02.3).
- 4. Have been an active member in good standing for a minimum of three (3) complete years of service at the time of application.
- 5. Have chaired or co-chaired an ICNY-related event and a Night of a Thousand Gowns (NOATG) committee.
- 6. Have attended a minimum of four (4) out of town coronations within two years preceding submitting the application.
- 7. Have excellent Communication Skills.
- 8. Actively participated in at least six (6) in-town Court related events.
- 9. Have performed in or hosted an ICNY Court related event.
- 10.Not been convicted of a felony within the last seven (7) years.
